PUBLICATIONS

Lifetime publications have been through a variety of outlets, including academic books, academic journal papers including many of the world's top economics journals, book chapters, both academic and for more popular audiences, reports, including for the Government and for the Office of Fair Trading, elementary explanations of complex ideas in non-academic articles, etc. In total I have written or co-written 4 books, edited 2 books, written around 75 learned journal articles and several book chapters. I have been cited over 6500 times in academic scholarly work (according to Google Scholar). Details of academic publications are attached. My academic publications span my entire career and I am still actively publishing and presenting work.

Academic publications have focused on Industrial Economics (Industrial Organization) both theoretical and empirical. Particular interests have included Consumer Behaviour, firms' reactions to this and related policy issues; Energy Economics, including both supply and generation aspects; Supermarket pricing behaviour; Transport policy.

Several of my research projects have been supported by competitively won grants. These have been obtained from the Engineering and Physical Sciences Research Council (six year grant ended June 2018; I was Principal Economist), the Economic and Social Research Council (one rated "outstanding" and the Leverhulme Trust, several as Principal Investigator.
