# 43/05-06 HR Framework

#### CONSIDERED:

Draft proposals for the implementation of the University's HR Framework (S.24/05-06).

## **RECOMMENDED:**

That the draft proposals for implementation of the University's HR Strategy be approved as set out in paper S.24/05-06, including:

- (a) the proposed new structure for academic careers to make Senior Lecturer the career grade for academic staff.
- (b) restructuring of probation arrangements to increase the length of probation from up to 4 years to 5 years.
- (c) the introduction of annual review for all staff to replace current University appraisal arrangements.
- (d) the use of merit increases for staff either within the incremental areas of the pay grades or in the extended areas at the tops of scales.

#### **RESOLVED:**

- (a) That the Vice-Chancellor proceed to seek to reach agreement with AUT on the proposals for a new University structure for academic careers as set out in paper S.24/05-06.
- (b) That the Senate endorse the position of the Academic Staff Committee on the importance of annual review in career development and in helping to resolve issues of poor performance.
- (c) That the issue of introducing a change to the nomenclature of academic staff titles be considered at the next meeting of the Senate to be held on 8 March 2006.
- (d) That the views of the Academic Staff Committee be sought on:
  - the appropriateness of removing the restriction on loading for probationary staff in years four and five of the new probationary period.
  - (ii) whether the title of Reader should be retained and if so for what period.
